ELIGIBILITY: This competition is open to competitors who are registered members of a Boy Scouts of America troop and have earned their Rifle Shooting Merit badge prior to the competition date.

**ADDITIONAL
EVENTS:**

- 1) Brock's Gap Training Center will host position shooting clinics for Prone, Kneeling and Standing positions. Clinics are open to all competitors. Please indicate whether you will be attending on your match registration form.
- 2) Competitors will have opportunity to try shotgun shooting. Pre-registration is not required.

ENTRY: Return the attached entry form, liability/publicity release form and registration fee to the address shown on the form by April 24, 2010. Everyone planning to be onsite at Brock's Gap Training Center, Inc. must have a liability release form on file at BGTC, Inc.

CATEGORIES: For individual rifle competition, scouts will be categorized by their current scout rank.

TEAMS: Teams will consist of 4 participants from the same scout unit. Teams may represent a troop or specific patrols within the troop. The team match is a "paper" match where the individual scores from each team member are added to get the team score. Team members must be declared before the first shot of any team member is fired.

RULES: Current NRA Smallbore rules will govern. All requirements in the "Guide to Safe Scouting Section VII Guns and Firearms" will be adhered to.

COURSE OF FIRE: Outdoor, 50 yard, 3x10 (10 shots in prone, standing and kneeling positions) on the NRA A23/5 target. Unlimited sighter shots.

- TIME LIMIT:** Firing time will be: 10 minutes prone, 20 minutes standing and 15 minutes kneeling. All sighter and record shots must be fired in the allotted time.
- FIREARM:** Rules 3.2 “Any Rifle” (see rulebook for specifications). Target rifles and ammunition will be provided by BGTC, Inc.
- EQUIPMENT:** All equipment specified in the NRA rulebook will be allowed except for special shooting jackets, pants and boots. Mats and kneeling rolls will be provided. A limited number of other equipment is available for use, but, competitors may want to bring their own binoculars for spotting shots. Eye protection is mandatory for everyone at Brock’s Gap Training Center and will be provided. Hearing protection is required for those close to the firing line and will be provided.
- SIGHTS:** Iron sights. Telescopic sights are not allowed.
- COACHING:** Limited coaching on the firing line will be permitted. Competitors and coaches must not disturb other competitors. Competitors with questions or problems may receive permission to leave the firing line from the Range Safety Officer.
- SCORING PROTESTS:** A scoring protest of \$1.00 per shot may be charged.
- TIES:** All ties will be broken in accordance with NRA Rules.
- AWARDS:** All competitors will receive a 2010 GAC Smallbore Championship patch. Awards will be presented to individual and team competitors. See award schedule.
- MAKE ENTRY:** Entries should be made using the entry form enclosed with this program. Mail entries to 574 Elvira Rd; Helena, AL 35080. E-mail inquiries to SRichieR@aol.com or call Mr. Sam Richardson at 205-424-8040.
- ENTRY FEES:** Advance entry: \$15.00 per shooter. \$15 per team.
Late entry: \$17 per shooter.
- ENTRIES CLOSE:** Advance entries will close April 24, 2010. Post entries will be accepted if space is available.
- CANCELLATIONS:** Cancellations received one week in advance, or earlier, will receive a full refund.

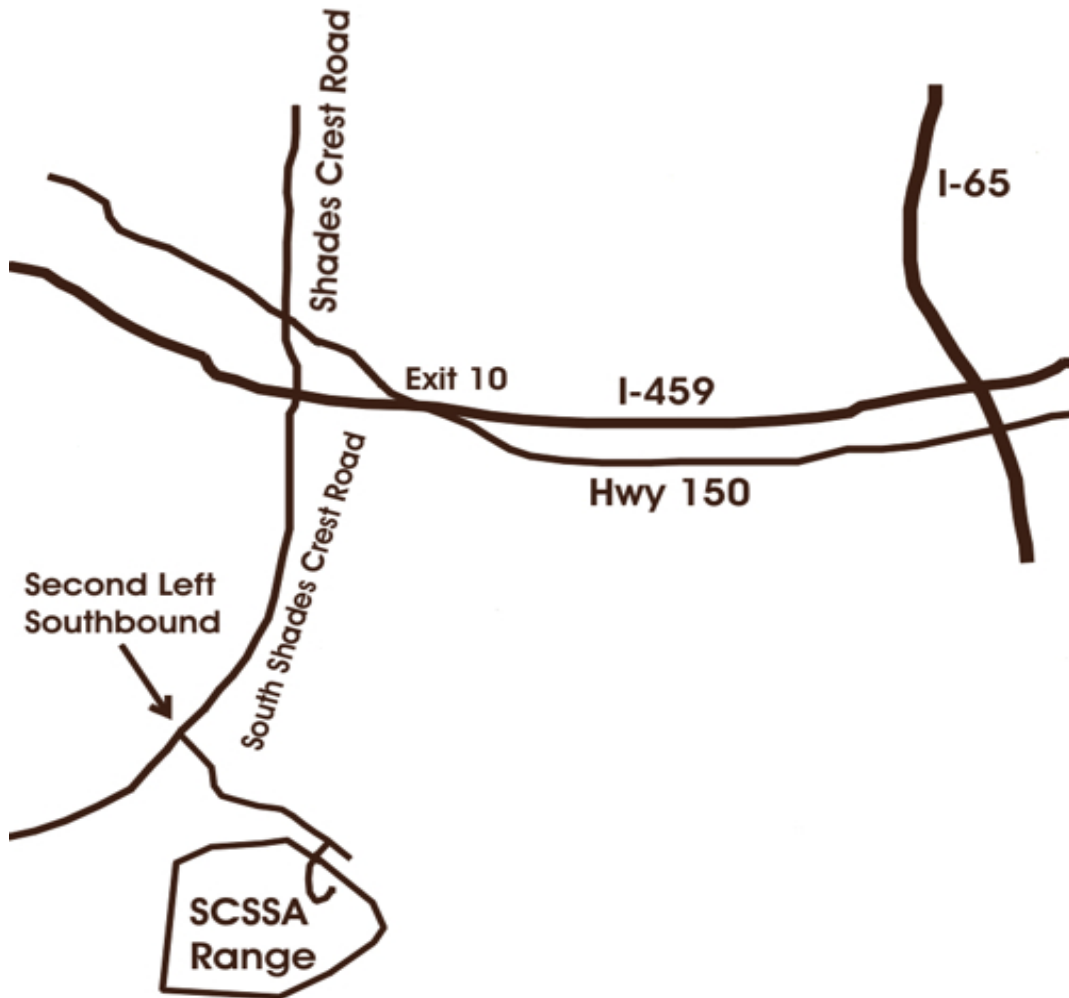
